Parrish Healthcare, in a press release dated April 8, 2021, announced its plan to convert the former Parrish Health & Fitness Center, located at 2210 Cheney Hwy (Hwy. 50), into an orthopedic and sports medicine center of excellence. The plan included closing the fitness center and opening a new Health & Wellness Center at 3065 Columbia Boulevard, Suite C 104, located inside the Cross Roads Market Place (Target) Shopping Plaza. At the height of the COVID-19 emergency, Parrish Healthcare closed its Parrish Health & Fitness Center to adhere to public health and safety guidelines. INNOVATIVE TECHNOLOGY FOR THE TREATMENT OF ADVANCED HEART DISEASE AVAILABLE ONLY AT PARRISH MEDICAL CENTER

Advanced heart disease treatment that reduces the risk for heart attack and stroke while increasing patient safety and comfort is now available in Brevard County, exclusively at Parrish Medical Center (PMC). Shockwave Intravascular Lithotripsy (IVL), uses sonic pressure waves to break up arterial calcium deposits that cause atherosclerosis (hardening of the arteries), which decreases blood flow and can also

lead to heart attacks and strokes. IVL was approved by the U.S. Food and Drug Administration (FDA) in Feb. 2021. "In our Cardiac Cath Lab, we are using IVL to treat complicated calcified coronary heart disease in a safer and easier way than ever before," said Cath Lab Director and Chairman of Medicine Dr. Biju Mathews. "With this technology we are able to achieve better lasting results through better lesion preparation and a higher degree of stent expansion that reduces the need for future procedures," says Dr. Mathews. The FDA describes how IVL is used to treat heart disease: "The lithotripsy emitters at the end of the catheter create pressure waves that are intended to break up the calcification that is restricting blood flow in the vessels of the heart. This helps open the blood vessels when the balloon is inflated (angioplasty). After using the Shockwave system, the doctor will implant a different device called a stent, which is a metal tube that helps keep the vessel open." More than 125 Floridians a day die of heart disease, making it the state's leading cause of death. Nationally, more than 600,000 people die annually of heart disease. As heart disease, specifically coronary calcification, progresses, plaque buildup on the arterial wall narrows and eventually restricts blood flow. IVL, as described, is a better way to bring a healing experience for cardiac patients. "Medical technology, once approved for use, is of value only to patients when they have access to it. We're delighted at PMC to be the only hospital in Brevard presently making IVL treatment available to patients in need of this vital service," said Dr. Mathews. Parrish's first IVL treatment was performed in November by Dr. Mathews. IVL is PMC's latest cardiovascular advancement offered as a part of the hospital's cardiovascular patient care services. PMC was also the first to offer other cardiovascular advancements such as the world's smallest pacemaker, the Micra AV. For more information visit parrishhealthcare.com/IVL. 

During this national take back event community members are able to surrender expired, unwanted or unused prescription controlledsubstances and other medications to law enforcement officers for destruction. Partnering for Person-Centered Care

It has been said that Parrish Medical Center was built as a beacon of hope and light to the northern Brevard community. The truth is this light comes not from the building itself but from the care partners who dedicate themselves to the scared work of healing day in and day out.

Amy is only 43 years old. Last month, she came to the Emergency Department with shortness of breath and chest pain. Amy was very worried about this visit due to her history of Hodgkin's lymphoma and cervical cancer. Testing in the ED proved that the suspicious-looking lesions in her lungs were indicative of malignant pleural mesothelioma, a rare and insidious cancer.

Until May, Amy was working as an electrician apprentice—well on her way to earning her certification. She was independent with her own apartment and vehicle. She was doing well until receiving her new diagnosis. She now requires oxygen, medications and follow-up care. She has no insurance and no family; her only friend lives in Georgia.

Knowing the support that was necessary for Amy, her care team worked creatively to ensure a healing discharge plan and a means to help her cope with her newfound challenges.

Lara Chicone, PMC's behavioral health social worker, fashioned for Amy a discharge plan which was possible due to Parrish's partnerships with community organizations. One such organization is Housing for the Homeless. Their program, Healing First, provides intensive case management services including furnished housing, food, clothes, hygiene items, etc. This assistance allows Amy to have a healing place to live while receiving the care she needs.

Amy continues to work with Parrish's Shannon Luker, Oncology Program coordinator. Shannon is teaching Amy about her diagnosis, as well as making sure she is registered with the American Cancer Society. Shannon has found five possible clinical trials for Amy; three of them that are available locally. Shannon's also helping Amy with care access, financial assistance, barrier-to-care removal, and emotional support.

Amy started this journey feeling alone. But she isn't. She has a "family," so to speak. A Parrish care partner family with a mission of *Healing Experiences for Everyone All the Time*. It's person-centered care. It's Parrish Healthcare.

A higher standard of care

When a patient expresses gratitude at receiving exceptional care, the shine of that statement reflects on all Parrish care partners.

Joseph, a patient who came to the Emergency Department, writes that he was seen immediately. Tests revealed he was suffering from COVID pneumonia. Joseph was admitted and moved to the 5th floor, where he remained for eight days.

Joseph said, "I received great care from all my nurses, CNAs, Dr. Aluino Ochoa and housekeeper Nikki Hicks-King. There are too many to name individually, but each of them demonstrated great patient care." More than that, he writes, they cared for *him* as a person – not his diagnosis or condition.

Joseph also said that Jennifer Lowe, a food and nutrition ambassador, "was great in providing nutritious, tasty meals." He was impressed that Jennifer phoned him daily to make sure his personalized meal requests were received.

Joseph said, "thank you for providing such a great hospital experience, proper treatment and a timely discharge." He says the care partners of Parrish Medical Center were so wonderful that he will recommend PMC to anyone needing care.

In his book, Radical Loving Care, Erie Chapman writes, "we all know that loving care is not required by either the law or by the Joint Commission. In the Healing Hospital, we do not deliver loving care because the law requires it, but because it's the right thing to do. It is a higher standard of care that Healing Hospitals set for themselves."

Each member of Joseph's care team lived our mission, vision, and values. That's more than clocking in, doing their jobs and clocking out. They created a sacred encounter by being present in the moment and making human connections. The team provided healing care, a combination of clinical care and loving care, furthering our mission of *Healing Experiences for Everyone all the Time* *.

"Good evening Mr. Mikitarian,

In the midst of all heartache surrounding us during these unprecedented times, I wanted to share what I believe to be a bright light in all sadness in the world right now.

My step-daughter, Candis, was recently in Parrish Medical Center from August 17 until she passed away from COVID this morning (9/2) at 8:05am. There is nothing good about COVID and how it has impacted our communities, however, there was so much good in the way the ICU team treated us, and more importantly, Candis.

I have worked in healthcare for over 20 years, and have seen the difference a compassionate vs. a disengaged 'just doing their job team' can make, and you, my friends, have an incredibly compassionate, empathetic, caring and professional team on the ICU.

Unfortunately, I do not have all the names of the team members we had the honor of interacting with, but I have quite a few, and hope you will take a few minutes to identify anyone else who cared for Candis while she was in the ICU, and not only recognize them for the extraordinary care of Candis, but every other patient in their care.

Lara Chicone, social worker; Melissa Muehlbrad, unit secretary; Ellen wright, registered nurse; Embily Smith, unit secretary; Kyra Ramos, registered nurse; Matthew Marti; registered nurse; Cortina Stickler, registered nurse; there were 2 security guards when we came to the hospital in the early morning on Sunday, 8/29; and the patient experience team. I am sure there were many more who treated Candis with the same respect and compassion as these healthcare heroes.

Kindness, caring and empathy are something that can't be measured on a balance sheet, but they certainly help the patient and families, and build the reputation of our facility.
